Dear Ms. Dippell:

Please accept attached Notice of Internal Corporate Reorganization submitted on behalf of NetFortris Acquisition Co. Inc. ("NetFortris"). NetFortris and its parent company, Sangoma US Inc. ("Sangoma US") expected to be consummated on June 30, 2025, whereby NetFortris will be consolidated into Sangoma US.

NetFortris is ceasing to exist as a VoIP provider and respectfully requests the cancellation of its authority as granted in DA-2015-0090 effective July 1, 2025.

The internal corporate reorganization does not reflect a transfer of control, because there will be no change in ownership or management of the company serving NetFortris customers.

**Request for Cancellation of Registrations of
NetFortris Acquisition Co, Inc. and Fonality Inc.**

NetFortris Acquisition Co, Inc. (“NetFortris”), Fonality Inc. (“Fonality”) and the parent company, Sangoma US Inc. (“Sangoma US”) (collectively, the “Parties”), notify the Commission of the internal reorganization expected to be consummated on June 30, 2025, whereby NetFortris and Fonality will be consolidated into Sangoma US.

NetFortris and Fonality will no longer operate within Missouri and therefore request the Commission to cancel the Authority of NetFortris and Fonality.

A description of the transaction is set forth below.

I. DESCRIPTION OF THE PARTIES

NetFortris Acquisition Co, Inc. is a corporation organized under the laws of the state of Delaware in 2013. NetFortris’s principal business address is 301 N Cattlemen Rd, Suite 300 Sarasota FL 34232. NetFortris registered with the Missouri Public Service Commission to provide VoIP services on October 27, 2014, Docket No. DA-2015-0090.

Fonality Inc. is a corporation organized under the laws of the state of Delaware in 2005. Fonality’s principal business address is 301 N Cattlemen Rd, Suite 301 Sarasota FL 34232. Fonality registered with the Missouri Public Service Commission to provide VoIP services on May 5, 2019, Docket No. DA-2019-0322.

Sangoma US Inc., is a corporation organized under the laws of the state of Delaware. Sangoma US’s principal business address is 301 N. Cattlemen Road, Suite 300, Sarasota, FL 34232. Sangoma US is registered with the Missouri Public Service Commission to provide VoIP services on December 12, 2016, Docket No. DA-2017-0144.

Sangoma US is the parent company of NetFortris and Fonality.

III. DESCRIPTION OF THE PROPOSED TRANSACTION

As part of an internal corporate reorganization, the Missouri customers of NetFortris Acquisition Co, Inc., Fonality Inc. and their parent company, NetFortris Corporation, are undertaking a corporate reorganization expected to be consummated in late June 2025.

The reorganization will commence with the liquidation of NetFortris Acquisition Co, Inc. with its customers and assets being distributed to NetFortris Corporation. Following this step, NetFortris Corporation and Fonality Inc. will be merged into Sangoma US Inc., which will be the surviving entity.

After the completion of this reorganization, NetFortris Acquisition Co, Inc., NetFortris Corporation, and Fonality Inc. will no longer exist as separate legal entities. All existing customers will be served by Sangoma US Inc. The corporate reorganization will not impact customers and service will continue under the current rates, terms, and conditions. A copy of the customer notice provided to NetFortris and Fonality customers is included as **Exhibit A**.¹

There will be no change to the management, corporate ownership, employees, rates, services, or other contract rights and obligations of the company serving NetFortris and Fonality customer base. All the current managerial, technical, and financial resources available to NetFortris and Fonality will remain available to Sangoma US. This corporate restructuring is in the public interest because it will allow Sangoma US to achieve administrative efficiencies and potential cost savings, thus financially strengthening the company without altering its operations in any respect.

Beginning July 1, 2025, Sangoma US Inc. will assume responsibility for all regulatory fees and assessments associated with NetFortris Acquisition Co, Inc. and Fonality Inc. customers.

IV. CONCLUSION

NetFortris Acquisition Co, Inc. and Fonality Inc. respectfully requests the Commission cancel the VoIP authorities for each of NetFortris Acquisition Co, Inc. and Fonality Inc., effective on July 1, 2025.
