**NOTICE OF CASE FILING**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or the Company) under 20 CSR 4240-4.017(1), hereby gives notice that it intends to file an application for a Certificate of Convenience and Necessity (CCN) under Section 393.170.1 for a new transmission switching station in Stoddard County, Missouri, as follows:

1. 20 CSR 4240-20.045 contain the requirements for applications to obtain CCNs for electric facilities.
2. Specifically, Ameren Missouri is proposing to construct a new transmission switching station to serve as the point-of interconnection with a renewable generation facility being developed by an unaffiliated entity.
3. The issues likely to be brought before the Missouri Public Service Commission in this case may include any matter related to the proposed transmission switching station and whether granting a CCN is "convenient or necessary" for public service, ascertained by an examination of the five (5) "Tartan" factors.
4. Ameren Missouri has had no communications with the Office of the Commission, as defined in 20 CSR 4240-4.015(10), respecting this matter during the 90 days preceding the filing of this notice.
