**NOTICE CONCERNING CONDITIONS**

**COMES NOW** Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) and for its *Notice of Concerning Conditions* states as follows to the Missouri Public Service Commission ("Commission"):

1. On December 19, 2024 (effective January 18, 2025), the Commission issued its *Order Approving Acquisition, Canceling Certificate and Granting Certificate of Convenience and Necessity* (“Order”) in this case. The Order approves the transfer of, and grants a Certificate of Convenience and Necessity for, the water assets of the Gascony Water Company.



The Order, among other things, requires Confluence Rivers to “. . . file notice in this case outlining completion of the above-recommended training, customer communications, notifications and billing for the acquired water system within ten (10) days after such communications and notifications.” (Order, p. 7, para. 14
