On February 3, 2020, Spire Missouri, Inc., filed its application requesting a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Lafayette County, Missouri, as an expansion of Spire's existing certificated area. On May 6, 2020, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, which directed Spire to file an updated tariff sheet to incorporate the described section of Lafayette County, Missouri.

On July 30, 2020, Spire filed a revised tariff sheet. The tariff sheet bears an effective date of August 29, 2020. The Commission will direct Staff to file a recommendation regarding the revised tariff sheet.

### THE COMMISSION ORDERS THAT:

1. No later than August 6, 2020, Staff shall file a recommendation regarding Spire's revised tariff sheet.

2. Any objections to Staff's recommendation shall be filed no later than August 11, 2020.
3. This order shall be effective when issued.
