ORDER SETTING PREHEARING CONFERENCE

On June 26, 2020, Missouri-American Water Company (MAWC) applied for an accounting authority order to permitting it to accumulate and defer to a regulatory asset for consideration of recovery in future rate case proceedings all extraordinary costs and financial impacts incurred as a result of the coronavirus (COVID-19) pandemic, plus associated carrying costs. The Commission issued notice and granted the intervention requests of Midwest Energy Consumers Group, the City of St. Joseph, Missouri, and the City of Riverside, Missouri.¹ The Commission will now set a prehearing conference.

THE COMMISSION ORDERS THAT:

1. The prehearing conference is set for August 10, 2020, at 1:30 p.m. Due to the COVID-19 pandemic, the conference will be held via WebEx video and telephone conference. Connection details will be sent to counsel for the parties via e-mail.
2. This order shall be effective when issued.
