On June 23, 2020, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri) filed an application seeking variance from certain provisions of Commission Rule 20 CSR 4240-20.100(8)(A), concerning information to be reported in Ameren Missouri's 2019 Renewable Energy Standard Compliance Report. On July 22, 2020, the Commission's Staff filed its recommendation on Ameren Missouri's application. Staff's recommendation does not expressly address Ameren Missouri's request for variance from the requirements of 20 CSR 4240-20.100(8)(A)1.J.

The Commission will direct the Commission's Staff to clarify whether its recommendation addresses variance of 20 CSR 4240-20.100(8)(A)1.J and to supplement its recommendation, if necessary.

THE COMMISSION ORDERS THAT:

1. No later than August 7, 2020, the Commission's Staff shall file a clarification or supplement to its recommendation, as described above, or a status report indicating when it expects to file such a supplement.

2. This order shall be effective when issued.
