## **NOTICE CLOSING FILE**

Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed what it described as a rate design case compliance filing on June 30, 2020. Evergy West indicated it made the filing to fulfill a requirement of a stipulation and agreement in its 2016 general rate case, ER-2016-0156. Evergy West did not request any action by the Commission.

The Commission's Staff responded to Evergy West's filing on July 10, 2020. Staff contends that Evergy West's filing is inadequate to fulfill the requirements of the stipulation and agreement. However, Staff explains that as Evergy West will need to file its next general rate case in 2021, it would be appropriate for the Commission to dismiss this case and for the company to concentrate on filing a proper rate design in that case. For that reason, Staff urged the Commission to dismiss this case.

Evergy West replied to Staff's response on July 23, 2020. Evergy West disagrees with Staff's criticisms of its filing, but agrees that as no Commission action is required at this time, the case should be dismissed.

The Commission agrees that no action by the Commission is required at this time. This file shall be closed.
