STATUS REPORT

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, “Evergy” or the “Company”),¹

1. In its *Order Requesting Procedural Schedule or Status Report*, the Commission directed the Parties² to file a procedural schedule or a status by July 7, 2025.

2. On July 7th, 2025, Staff, after discussion with the Parties filed a *Status Report* requesting additional time until July 15th, 2025, so the Parties could continue discussing a settlement.

3. The Parties are continuing to discuss settlement and again request additional time to file a response to the Commission. The Parties request an additional week until July 22nd, 2025.

WHEREFORE, Evergy respectfully requests that the Commission accept this status report, grant the Parties additional time to file is responses herein as set forth above, and to grant such other and further relief as the Commission considers appropriate.
