**SUPPLEMENTAL FILING TO THE APPLICATION AND VERIFICATION OF
BOYCOM CABLEVISION, INC.
FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER
IN THE STATE OF MISSOURI**

Boycom Cablevision, Inc, (“Boycom”) by its undersigned counsel, hereby submits this Supplemental Filing to its Application for Designation as an Eligible Telecommunications Carrier (“ETC”) in the State of Missouri clarifying the service area it is seeking for ETC designation.

Boycom is currently registered as an interconnected VoIP provider in the State of Missouri with authority to serve on a statewide basis.¹ Boycom wishes to clarify and amend its Application by noting that it is not seeking ETC authority on a statewide basis but rather is seeking ETC authorization for the following areas, with an asterisk identifying the current areas served:

- *Poplar Bluff
- *Ellsinore
- *Van Buren
- *Mill Spring
- *Piedmont
- *Patterson
- Greenville
- *Wappapello
- *Williamsville

Accordingly, Boycom supplements its application by deleting Section IV.2 in its entirety and replacing it with the following:

Boycom's Proposed ETC Service Area

Boycom does not request ETC designation on a statewide basis but rather requests ETC designation for the communities and surrounding areas of Poplar Bluff, Ellsinore, Van Buren, Mill Spring, Piedmont, Patterson, Greenville, Wappapello, Williamsville, Neelyville, Naylor, Harviell, Fairdealing, Grandin and Qulin

In addition, Boycom supplements its Application for clarification by deleting Section VI in its entirety and replacing it with the following:

For the reasons stated herein, Boycom respectfully requests that the Commission designate Boycom as an ETC in the areas identified in Section IV.2 above on an expedited basis and order such other relief as may be appropriate.
