ORDER ALLOWING AMENDMENT OF COMPLAINT

Issue Date: August 10, 2020

Effective Date: August 10, 2020

On June 22, 2020,¹ the Complainants filed a Formal Complaint which identified Grain Belt Express Clean Line LLC as a Respondent. On August 7, Complainants filed a Motion to Amend Complaint. The motion acknowledged that in footnote 1 of their Response to Formal Complaint, Respondents correctly noted that prior to the filing of the Complaint, the name of that corporate entity had been changed to Grain Belt Express LLC. Complainants ask leave to amend their Complaint by interlineation as follows:

- (1) In the style of the case, the name “Grain Belt Express Clean Line LLC” should be changed to “Grain Belt Express LLC”;
- (2) In the first line of paragraph 3 of the Complaint, the parenthetical “(Grain Belt)” should be deleted.

(3) After the first sentence in paragraph 3 of the Complaint, the following sentence should be added: "As indicated in Commission Case No. EN-2020-0358, the name Grain Belt Express Clean Line LLC was thereafter changed to Grain Belt Express LLC (hereafter Grain Belt)."

The Commission will sustain the motion.

THE COMMISSION ORDERS THAT:

1. Complainant's Motion to Amend Complaint is sustained. The Complaint shall be deemed amended by interlineation as described in the body of this order.
2. The Data Center shall make all such changes in EFIS with respect to parties as may be deemed necessary or appropriate because of this order.
3. This order shall be effective when issued.
