### ORDER DIRECTING FILING

On June 23, 2020, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri) filed an application seeking variance from certain provisions of Commission Rule 20 CSR 4240-20.100(8)(A). On July 22, 2020, the Commission's Staff filed its recommendation on Ameren Missouri's application. At the Commission's request, on August 7, 2020, Staff filed a supplement to its recommendation to address Ameren Missouri's request for variance from the requirements of 20 CSR 4240-20.100(8)(A)1.J. Staff recommended Ameren Missouri's variance request be denied in regard to 20 CSR 4240-20.100(8)(A)1.J based on the reasoning that no variance is necessary and Ameren Missouri provided adequate information in its 2019 Renewable Energy Standard Compliance Report.

On August 10, 2020, Ameren Missouri filed a response in which it (1) agreed it does not require a variance from 20 CSR 4240-20.100(8)(A)1.J with regard to its 2019 RES Compliance Report; (2) asserted that it may need to request a variance from 20 CSR 4240-20.100(8)(A)1.J in the future; and (3) renewed its request for variance of a different portion of the rule, 20 CSR 4240-20.100(8)(A)1.I.

The Commission will direct Ameren Missouri to clarify whether it has withdrawn its request for a variance of Commission Rule 20 CSR 4240-20.100(8)(A)1.J in this case.

### THE COMMISSION ORDERS THAT:

- 1. No later than August 17, 2020, Ameren Missouri shall file a clarification, as described above.
  - 2. This order shall be effective when issued.
