Therefore, the Commission will move the location of the local public hearing to be held on Monday, July 21 from Corley Hall to the Mills Anderson Justice Center Auditorium.

1. The location for the local public hearing, which is scheduled for Monday, July 21, 2025, at 6:00 p.m. shall be changed to the Mills Anderson Justice Center Auditorium, 3350 Newman Road, Joplin, Missouri.
