On March 11, 2020, Confluence Rivers Utility Operating Company, Inc., applied for authority to acquire sewer and water utility assets in transactions with various entities.<sup>1</sup>

On July 17, 2020, the Commission's Staff filed its recommendation. On July 20, 2020, the Office of the Public Counsel (OPC) filed a *Motion to Suspend Current Schedule, Request for Notice to Customers, and Request for Local Public Hearing*. Based on OPC's request, the Commission suspended any deadline for response to Staff's July 17, 2020 recommendation. After receiving responses from Confluence Rivers and Staff, the Commission scheduled a virtual public hearing, which was conducted on August 13, 2020. The Commission will now provide a deadline for responses to Staff's recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. No later than August 24, 2020, Confluence Rivers and OPC may file responses to Staff's recommendation, filed on July 17, 2020.
  - 2. This order shall be effective when issued.
