On June 15, 2020,² the Commission issued its Order Directing Notice and Establishing Time for Filings. This Order directed Staff to file a pleading no later than July 7 advising when it anticipated filing its recommendation in this matter. On July 7, Staff filed a Status Report requesting the Commission order Staff to file its recommendation no later than August 21. The Commission did so. On August 14, the Staff filed a Motion for Extension, requesting the deadline be extended to September 18, explaining that responses to its data requests to Confluence Rivers and Terre Du Lac had required follow-up data requests, with responses not due until August 26. The Commission will sustain Staff's motion.

THE COMMISSION ORDERS THAT:

1. The Commission Staff's Motion for Extension is sustained.
2. No later than September 18, 2020, the Commission Staff shall file its recommendation.
3. This Order shall be effective when issued.
