ORDER SUSPENDING TARIFF

On August 19, 2020, Liberty Utilities (Midstates Natural Gas Corp.) (Liberty) filed a tariff that would change a weather station used to generate data for determining the Company's Weather Normalization Adjustment Rider ("WNAR") rate to be charged to Liberty's customers. The tariff bears an effective date of September 18, 2020.

On August 21, 2020, the Staff of the Commission filed a Motion to Suspend Tariff Sheet. Staff explains that it needs additional time beyond September 18, 2020 to complete discovery. Staff states that it plans to file its Recommendation by September 18, 2020.

Because the tariffs effective dates do not allow the Commission and its Staff sufficient time to review the applications, the Commission will suspend the tariffs. The Commission will also order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The tariff sheet assigned Tracking Nos. JG-2021-0042 is suspended until October 18, 2020.
2. The Staff of the Commission shall file its Recommendation no later than September 18, 2020.
3. This order shall be effective when issued.
