On July 31, 2020, the Staff of the Missouri Public Service Commission ("Staff") filed its Staff Recommendation ("Recommendation"). The Recommendation, in the attached Memorandum, Section 5.2.2, states that Spire Missouri, Inc. ("Spire") provided its current Distribution Integrity Management Program (DIMP) to Staff in January 2020.

The Commission will direct Staff to submit Spire's DIMP as a part of this file. The DIMP may be submitted as confidential if appropriate. If the DIMP cannot be filed, the Commission requests a filing explaining why it cannot.

THE COMMISSION ORDERS THAT:

1. Staff shall file the DIMP or an explanatory status report no later than noon on Friday, August 28, 2020.
2. This order shall be effective when issued.
