### ORDER CONFIRMING EVIDENTIARY HEARING DATE

Issue Date: July 18, 2025 Effective Date: July 18, 2025

On January 16, 2025, Jim Moriarty filed a complaint against Missouri American Water Company. On May 14, 2025. Staff filed a recommendation. Pursuant to a June 2, 2025 Order, on June 3, 2025, Complainant, and on June 9, 2025, Staff Counsel filed Procedural Schedules. On June 16, 2025, the Commission issued an Order setting a hearing date of August 28, 2025 and issued a Procedural Schedule. On June 17, 2025, Missouri American Water Company filed a *Motion to Revise Procedural Schedule*. None of the hearing dates proposed by the Attorneys for Missouri American Water Company are available and their witnesses are available on August 28, 2025.

On June 23, 2025 the Commission requested information about the attorney's availability for a set hearing date. On June 25, 2025, one of three attorneys' for Missouri American Water responded that she has a conflict and cannot participate in the hearing. Both Staff Counsel and Missouri-American Water filed several conflict dates each for the coming months. Scheduling conflicts make it impossible to move the hearing date and as two of the three attorneys for Missouri-American Water are available, the Commission will

order the hearing to proceed as scheduled. The procedural schedule will remain the same with the addition that post hearing briefs will be filed as necessary.

### THE COMMISSION ORDERS THAT:

- 1. The hearing will be on August 28, 2025.
- 2. The Procedural Schedule will be the same as previously ordered with the addition of post hearing briefs if necessary.
  - 3. This order is effective when issued.
