ORDER DIRECTING EXPEDITED FILING

On March 2, 2020, The Raytown Water Company filed a letter requesting an increase in its annual overall operating revenues in a staff assisted rate case. On August 4, 2020, the Commission's Staff, Raytown Water and the Office of the Public Counsel (OPC) filed a unanimous disposition agreement to fully resolve Raytown Water Company's request.

On August 10, 2020, Raytown Water filed seven tariff sheets. On August 18, 2020, Staff recommended approval of four of the tariff sheets. Raytown Water on August 19, 2020, withdrew the three tariff sheets disapproved by Staff, including a sheet titled: P.S.C. MO No. 5 2nd Revised Sheet No. 10, Cancelling 1st Revised Sheet No. 10. On August 26, 2020, the Commission issued its *Order Approving Unanimous Disposition Agreement*. Effective September 8, 2020, the Commission's order approves four tariff sheets filed in Tariff No. YW-2021-0022, consistent with Staff's recommendation.

On August 26, 2020, Raytown Water filed a tariff revision, submitting a sheet titled: P.S.C. MO No. 5 2nd Revised Sheet No. 10, Cancelling 1st Revised Sheet No. 10. The tariff sheet, filed under Tariff No. YW-2021-0047, bears a purported issue date of August 9, 2020, and an effective date of September 8, 2020.

The Commission will order Staff to file a recommendation regarding whether the tariff sheet filed on August 26, 2020, in Tariff No. YW-2021-0047 complies with the Commission's August 26, 2020, order and the parties' unanimous disposition agreement and should otherwise be approved. In addition, Staff's recommendation must specify the reasons, if any, why the revised tariff must be effective on September 8, 2020, and the harm that would occur if the tariff took effect at a later date. OPC may also respond.

THE COMMISSION ORDERS THAT:

- 1. No later than 12 p.m. (noon) August 28, 2020, Staff shall file a recommendation, as described above.
- 2. The Office of the Public Counsel may file a response to the tariff filing in YW-2021-0047 no later than 12 p.m. (noon) August 28, 2020.
 - 3. This order shall be effective when issued.
