SECOND SUPPLEMENTAL PROCEDURAL ORDER

On August 14, 2020, the Commission issued its Order Directing Filing, ordering the parties to file new proposed hearing dates. The parties have complied, and the Commission will set the case for an evidentiary hearing on October 13, 2020. Because of the COVID19 Virus, the Commission will set the matter for video conference hearing and issue orders concerning affected procedural matters. The Commission will issue further orders as become necessary accommodating any party or witness's ability to participate in the hearing.

THE COMMISSION ORDERS THAT:

1. The case is set for a video conference evidentiary hearing on October 13, 2020, commencing at 10:00 a.m. Any party or witness may participate by telephone only.

3. All exhibits shall be pre-filed with the Commission in EFIS. Ms. Stinnett's exhibits shall be numbered 1 through 100; Respondent's shall be numbered 101 through 200; and the Commission Staff's exhibits shall be numbered 201 through 300.

4. The parties shall file position statements no later than October 6, 2020.

5. Ms. Stinnett may consult with the Commission Staff, who shall assist her in complying with this order.

6. To the extent not inconsistent with this order, all prior orders shall remain in full force and effect.

7. This order shall be effective when issued.
