**NOTICE OF EXTENSION OF PROGRAM YEAR ("PY") 2017 EVALUATION,
MEASUREMENT & VALUATION ("EM&V") ACTIVITY/REPORT TIMELINE**

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and hereby files notice of its extension of the PY2017 EM&V activity/report timeline. This extension is necessary to accommodate the informal extension of time from October 27, 2018 to November 9, 2018 allowed the EM&V evaluator (Navigant) to issue its PY2017 Final Draft EM&V Report. Because Navigant requires two additional weeks to complete its draft report, Navigant will issue its PY2017 Final EM&V Report no later than December 25, 2018 (originally due December 11, 2018).

As a result of Navigant's two week extension, the Commission's Auditor, Mr. Steve Grover of Evergreen Economics, requires a one week extension from January 4, 2019 to January 11, 2019 to submit the Final PSC Auditor Report. As well, Mr. Grover requires a one week extension due to a preplanned vacation over the holiday period.

The extended PY2017 EM&V timeline prejudices no party or stakeholder and is a reasonable accommodation to allow the Auditor sufficient time to complete its report in light of the additional time needed by Navigant.

Extended PY2017 EM&V Activity/Report Timeline

November 9, 2018	Final Draft EM&V Report due
November 30, 2018	Stakeholder comments to Final Draft Report are due to the Company, all participating stakeholders, EM&V PSC Auditor and EM&V evaluator (Navigant)
December 10, 2018	EM&V evaluator-initiated conference call with the stakeholder group and Auditor regarding stakeholder comments
December 25, 2018	Final EM&V Report due
January 11, 2019	Final PSC Auditor Report due
January 22, 2019	End of grace period; due date to file EM&V impact change request
January 28, 2019	Conference call (if needed)
February 12, 2019	Stakeholder(s) due date to file responses to EM&V impact change requests
March 25, 2019	Evidentiary hearings completed (if necessary)
April 24, 2019	Commission order resolving change requests
April 24, 2019	PY2017 EM&V results final

WHEREFORE, the Staff submits its notice of extension of PY2017 EM&V activity/report timeline resulting from the two week extension of time needed by Navigant to complete its draft and final PY2017 EM&V reports.
