ORDER CANCELLING REGISTRATION

Issue Date: July 22, 2025

Effective Date: August 1, 2025

On July 11, 2025, NetFortris Acquisition Co., Inc. (NetFortris) filed a letter notifying the Commission that it no longer wished to retain its registration to provide Interconnected Voice over Internet Protocol (IVoIP) services in Missouri. The letter states that NetFortris is ceasing to exist as an IVoIP provider due to it being consolidated into Sangoma US Inc., its parent company. The Commission granted NetFortris its IVoIP registration in the State of Missouri in Case No. DA-2015-0090.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority or registration by filing a letter signed by the company's official that identifies when and which certificate, registration, and any applicable tariff to cancel. Based on the request of NetFortris, the Commission finds that the IVoIP registration granted to it shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to NetFortris Acquisition Co., Inc. in Case Number DA-2015-0090, is cancelled.
2. This order shall become effective on August 1, 2025.
3. This case may be closed on August 2, 2025.
