## ORDER ESTABLISHING TIME TO RESPOND

Issue Date: July 22, 2025

Effective Date: July 22, 2025

On July 22, 2025, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel the registration to provide interconnected voice over internet protocol (IVoIP) services for ConnectMe, LLC (ConnectMe). The Commission granted ConnectMe a registration to provide IVoIP services in Case No. DA-2016-0004.

Subsection 392.550(6), RSMo, provides that the Commission may revoke an IVoIP registration for failure to comply with the requirements of Section 392.550, RSMo. The requirements of Section 392.550 include filing annual reports and Statements of Revenue as prescribed by the Commission.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than August 1, 2025.
2. This order shall be effective when issued.
