ORDER DIRECTING FILING

On January 21, 2020,¹ the Commission issued its Order Granting Certificate of Convenience and Necessity to Missouri-American Water Company (MAWC) to construct, install, own, operate, control, manage, and maintain a sewer system in the Clinton Estates service area described in the order. The order's effective date was February 20. The order required MAWC to submit new and revised tariff sheets, to become effective before closing on the assets, to notify the Commission of closing on the assets within five days after closing, and to submit status reports every 30 days, as specifically described in the order, if closing on the sewer system assets did not occur within 30 days after the effective date of the order.

On March 23, MAWC filed a status report that stated there were easement issues and no closing date had been set. MAWC filed status reports on April 21, May 20, and June 22, making the same report. On July 24, MAWC reported that a plan to acquire the easement would be presented to Clinton County in August and that MAWC anticipated a closing shortly thereafter. MAWC has not, following July 24, either notified the

Commission a closing has occurred or otherwise filed further status reports. The Commission will order MAWC to file a status report and otherwise to continue to comply with its January 21 status report orders.

THE COMMISSION ORDERS THAT:

1. MAWC shall file a status report no later than September 14, 2020.
2. If closing on the sewer system assets does not occur within thirty days following September 14, 2020, MAWC shall submit a status report within five days after this thirty-day period regarding the status of closing, and additional status reports within five days after each additional thirty-day period, until closing takes place, or until MAWC determines the transfer of assets will not occur.
3. This Order shall be effective when issued.
