Barbara Edwards, Complainant, filed a complaint with the Commission on February 24, 2020, against Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("Evergy Missouri"). This matter is set for hearing on September 24, 2020, in Jefferson City, Missouri, as agreed by the parties.

On August 17, 2020, Evergy Missouri filed a request that Alicia Duarte, a senior customer care advisor, be allowed to appear by telephone or video because of her responsibility as a primary caregiver to her father. On September 9, 2020, the Commission issued its *Order Allowing Remote Appearance at Hearing*.

The Commission will now establish the conference line to be used for any remote appearance permitted at hearing of this matter, unless revised by further order.
