On April 22, 2015, Kansas City Power & Light Company filed the above-referenced report. The Commission received timely intervention requests from: Earth Island Institute, d/b/a Renew Missouri; Missouri Industrial Energy Consumers; Brightergy, LLC; and the Missouri Division of Energy. Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless the Commission orders otherwise. The Commission issued no order to the contrary, ten days have elapsed since the applications to intervene were filed, and the Commission received no responses to those applications.
