## ORDER DIRECTING RESPONSES TO REQUEST FOR NOTICE AND REQUEST FOR PUBLIC HEARING

On June 12, 2020,<sup>2</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence) filed an Application and Motion for Waiver requesting authority to purchase substantially all of the water and/or sewer assets of Terre Du Lac Utilities Corporation (Terre Du Lac). On September 18, the Commission Staff (Staff) filed its Recommendation. On September 21, the Office of the Public Counsel (OPC) filed a Motion to Suspend Current Schedule, Request for Notice to Customers, and Request for Local Public Hearing. The Commission will direct Confluence and Staff to file responses to OPC's requests for notice and local public hearing. To enable the Commission to consider the parties' responses, the Commission will suspend the obligation to respond to Staff's September 18 recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than September 29, 2020, Confluence and Staff shall file a response to OPC's request for notice to customers and for local public hearing.
