An evidentiary hearing was scheduled in this matter on July 24, 2020. On July 23, 2020, Spire Missouri Inc. filed a *Motion for Continuance*, requesting the Commission continue the hearing to allow Spire to exchange Complainant's meter at Complainant's request.
