On August 24, 2020, Roeslein Alternative Energy Services, LLC filed an application requesting waiver of compliance with gas odorization required by 20 CSR 4240-40.030(12)(P) in operation of a gas transmission line in Putnam County, Missouri.

The Commission ordered its Staff to file, no later than September 24, 2020, a recommendation or a status report indicating when it expects to file a recommendation. Staff filed a status report on September 24, 2020, and advised data requests are currently pending, Staff is now coordinating with federal authorities regarding the request, additional data requests are anticipated, and Staff is scheduled to conduct a site visit on October 21. The status report indicates Staff intends to file its recommendation in this matter no later than December 8, 2020.

The Commission will direct Staff to file its recommendation as anticipated.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Roeslein Alternative Energy Services, LLC's application no later than December 8, 2020.
2. This order shall be effective when issued.
