ORDER DIRECTING FILING

On August 7, 2020, A Net, LLC, applied for designation as a federal broadband lifeline-only eligible telecommunications carrier (ETC) in three Missouri counties: Lafayette, Saline, and Johnson. On August 10, 2020, the Commission issued its *Order Directing Notice and Setting Deadlines for Intervention Applications and Staff's Recommendation*. The Commission ordered its Staff to file, no later than September 28, 2020, a recommendation or a status report indicating when it expects to file a recommendation.

Staff filed a "motion to extend" on September 28, 2020, and advised A Net's application does not comply in full with Commission rules concerning ETC applications. Staff's report indicates it has advised A Net of the deficiencies and A Net has confirmed it will supplement its application. Staff requests an extension to allow it to file its recommendation 10 business days after A Net files a supplement of its application.

The Commission will direct Staff to file its recommendation as anticipated.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding A Net, LLC's application no later than 10 business days after A Net files a supplement to its application.

2. This order shall be effective when issued.
