ORDER TO FILE PROPOSED LOCAL PUBLIC HEARING SCHEDULE, SETTING PROCEDURAL CONFERENCE, AND ORDER FOR FILING

On June 12, 2020,² Confluence Rivers Utility Operating Company, Inc. (Confluence) filed an Application and Motion for Waiver. On June 15, the Commission issued its Order Directing Notice and Establishing Time for Filings. On July 7 and August 14, the Commission issued orders directing the Commission Staff to file a recommendation. On September 18, Staff filed its recommendation. On September 21, the Office of Public Counsel (OPC) filed a Motion to Suspend Current Schedule, Request for Notice to Customers, and Request for Local Public Hearing (OPC's Motion).

On September 22, the Commission issued its Order Directing Responses to Request for Notice and Request for Public Hearing. Therein, the Commission suspended the deadline for responding to Staff's September 18 recommendation and ordered Confluence and Staff to respond to OPC's request for notice to customers and for local public hearing. On September 28 and 29 respectively, Confluence and Staff filed their responses to OPC's Motion. Both agreed to public hearings, but neither agreed to the suspension of the procedural schedule. Additionally, in response to OPC's request for

notice to customers, Staff stated it had no objections, and Confluence stated it had sent the customer letter provided in Appendix A of its pleading to current customers of Terre Du Lac on August 12 (Confluence's notice response).

The Commission will order Staff and OPC to file replies to Confluence's notice response, order the parties to file a proposed local public hearing schedule, and set the case for a procedural conference.

THE COMMISSION ORDERS THAT:

1. No later than October 7, 2020, Staff and OPC shall file replies to Confluence's notice response.
2. No later than October 26, 2020, the parties shall file a proposed local public hearing schedule.
3. A procedural conference is set for October 27, 2020 at 10:00 a.m. Due to the COVID-19 pandemic, the conference will be conducted by WebEx video and telephone conference connection. Details will be emailed to counsel.
4. This order shall be effective when issued.
