On July 23, 2020,<sup>1</sup> the parties filed a Stipulation and Agreement (agreement), and the Commission issued its Order Suspending Procedural Orders and Cancelling Evidentiary Hearing. On September 29, the Commission Staff filed a Request for Ruling on Stipulation. The Commission has reviewed the agreement. No part of the actual agreement requires it be confidential. But it was filed with the Commission as “confidential in its entirety.” The Commission will order the parties to identify what parts if any are to be deemed confidential and state why.

**THE COMMISSION ORDERS THAT:**

1. No later than October 8, 2020, the parties shall file pleadings designating what parts of their agreement, if any, are to be deemed confidential; and for each part so designated, stating their reasons fully and with complete particularity.
