ORDER GRANTING JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE

On September 17, 2020, the parties jointly filed a motion to suspend the procedural schedule. The parties explain that they have been engaged in fruitful settlement discussions and are hopeful that an agreement will be forthcoming. In order to accommodate a continuation of those settlement discussions, the parties request the procedural schedule in this matter be suspended. The parties also state that they will inform the Commission of the status of their negotiations no later than October 9, 2020.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Joint Motion to Suspend Procedural Schedule is granted.
2. The procedural deadlines and dates set for proceedings, including the evidentiary hearing set on November 12-13, 2020, are canceled.
3. The parties shall file a status report no later than October 9, 2020.
4. This order shall be effective when issued.
