The Order required Confluence to file Adoption Notice tariff sheets within ten days after closing on the purchase.

On October 5, 2020, Confluence filed its tariff sheets under Tariff Nos. YS-2021-0094 and YW-2021-0093. The effective date of the tariff sheets is November 4, 2020. The Commission will direct its Staff to file a recommendation as to whether the tariff sheets comply with the Commission's Order.
