## ORDER DIRECTING STAFF REVIEW

On August 26, 2020, the Commission issued its Report and Order (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence) authority to purchase Port Perry Service Company, which provides both water and sewer service in areas of unincorporated Perry County. The Order required Confluence to file Adoption Notice tariff sheets within ten days after closing on the purchase.

On October 5, 2020, Confluence filed its tariff sheets under Tariff Nos. YS-2021-0094 and YW-2021-0093. The effective date of the tariff sheets is November 4, 2020. The Commission will direct its Staff to file a recommendation as to whether the tariff sheets comply with the Commission's Order.

### THE COMMISSION ORDERS THAT:

1. No later than October 19, 2020, Staff shall file a recommendation as directed in the body of this order.
2. This order shall be effective when issued.
