NOTICE AND ORDER

On August 31, 2020, the Commission issued its Second Supplemental Procedural Order setting the case for a video conference evidentiary hearing on October 13, 2020, commencing at 10:00 a.m. The order provided that any party or witness might participate by telephone only and ordered all parties to provide email addresses. It also provided for the pre-filing and numbering of exhibits, set a deadline for position statements, and authorized Ms. Stinnett and the Commission Staff to consult on complying with the order. The Commission will issue notices and orders that Ms. Stinnett and the regulatory law judge will attend the hearing at the offices of the Public Service Commission in Jefferson City, Missouri, while other parties, attorneys, and witnesses shall participate only by video conference hearing or telephone as previously ordered.

THE COMMISSION ORDERS THAT:

1. Patricia Sue Stinnett shall appear and participate in her hearing in this case at 10:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 305. Because of the COVID 19 pandemic, all

persons except for the regulatory law judge and the Petitioner may participate in the hearing only by video conferencing or telephone as previously ordered.

2. To the extent not inconsistent with this order, all prior orders shall remain in full force and effect.

3. This order shall be effective when issued.
