ORDER EXTENDING DEADLINES

Effective Date: October 9, 2020

On September 16, 2020,¹ the Commission reopened the record in this case and ordered MAWC to file its records showing it either complied with or had a waiver from the requirements of Commission Rule 20 CSR 4240-10.030(38) with respect to Ms. Beecham's water meter. On September 25, MAWC filed its Affidavit of Tracie Figueroa (MAWC's Affidavit) in response to the order. On September 29, the Commission ordered MAWC to clarify its response no later than October 9 and Staff to file a report no later than October 15. On October 9, MAWC and Staff jointly asked for an extension of those deadlines by one week, explaining they needed time to discuss the case with each other and to clarify their responses. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. The Joint Motion for Extension for Filing Responses to Order Directing Filing is granted.
2. No later than October 16, 2020, MAWC shall clarify its previous response in MAWC's Affidavit regarding its compliance with the 10 year inspection and testing requirement of 20 CSR 4240-10.030(38).
3. No later than October 23, 2020, the Commission Staff shall file a report concerning MAWC's Affidavit.
4. Responses to the Commission Staff's report shall be filed no later than October 30, 2020.
5. Objections to the receipt of MAWC's Affidavit and subsequent clarification, as well as Staff's report, into evidence shall be filed no later than October 30, 2020.
6. This order shall be effective when issued.
