On March 11, 2020, Confluence Rivers Utility Operating Company, Inc., applied for authority to acquire sewer and water utility assets in transactions with various entities.<sup>1</sup>

On September 23, 2020, the Commission directed Staff to respond to Commission inquiries no later than October 7, 2020, with a supplement to Staff's recommendation or a status report stating when Staff will be able to respond in full. The Commission's inquiries included a request for all photos from Staff's inspection of the subject systems. On October 7, 2020, Staff filed its response and indicated it requires additional time to organize and prepare the photos for filing. The response indicates Staff can complete the filing by no later than October 14, 2020.

The Commission will suspend until further order Staff's obligation to file photos in response to the Commission's inquiry.

#### THE COMMISSION ORDERS THAT:

1. Staff's obligation to file photos in response to the Commission's inquiry is suspended until further order.
