ORDER SETTING TIME FOR EXHIBIT FILING, OBJECTIONS TO EXHIBITS AND BRIEFS

Issue Date: October 14, 2020

Effective Date: October 14, 2020

An evidentiary hearing in this matter was held on October 13, 2020. At the hearing, Ms. Stinnett sought to introduce into evidence several exhibits. Those exhibits, enumerated one through nine, were emailed to the parties. The regulatory law judge directed that any objections to the exhibits be filed in writing. The Commission will set a deadline for filing objections.

At the regulatory judge's request, Respondent offered to file any contractual services agreement related to the complaint's subject pole lighting as an exhibit. The Commission will set a deadline to file the exhibit and for any objections to that exhibit.

The Commission will order its Staff and Respondent to file briefs. In addition to arguing their respective positions, Staff and Respondent shall specifically address whether the charges in question were "overcharges" within the meaning of that term as used in 20 CSR 4240-13.025. Respondent shall include in any brief a citation to its private lighting tariff sheet relevant to the subject pole lighting rates. Ms. Stinnett may file a brief,

but is not required to. The parties shall cite to the relevant portions of the record, with particularity, to support their positions

IT IS ORDERED THAT:

1. Any objections to Ms. Stinnent's exhibits one through nine shall be filed no later than October 23, 2020.
2. Respondent shall file any services agreement contract regarding the subject pole lights as an exhibit no later than October 19, 2020. Any objections to the services agreement contract shall be filed no later than October 26, 2020. If no services agreement contract exists, Respondent shall file a statement to that effect.
3. Briefs shall be filed no later than November 12, 2020.
4. This order is effective when issued.
