On July 23, 2020, the Missouri Public Service Commission issued an *Amended Report and Order* effective August 2, 2020, regarding The Empire District Electric Company's request for a rate increase. On July 31, 2020, The Empire District Electric Company and the Office of the Public Counsel filed timely applications for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the applications for rehearing do not demonstrate sufficient reason to rehear the matter.

The Commission will deny the applications for rehearing.

**THE COMMISSION ORDERS THAT:**

1. The Empire District Electric Company's *Application for Rehearing* filed on July 31, 2020, is denied.
2. The Office of the Public Counsel's *Second Application for Rehearing* filed

on July 31, 2020, is denied.
