ORDER APPROVING RECONCILIATION OF CONTESTED ISSUES

Section 386.420.4, RSMo 2016, requires the Commission to prepare and approve a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues decided by the Commission in this rate case. The law requires the Commission to allow the parties an opportunity to provide written input regarding that reconciliation.

On September 24, 2020, The Empire District Electric Company (Empire) filed an amended reconciliation. The Commission's Staff filed a response recommending that the Commission approve the amended reconciliation. The Commission directed any party wishing to respond to the amended reconciliation to do so by October 2, 2020. No additional responses were received.

The Commission finds that the reconciliation submitted by Empire is an accurate representation of the dollar value and rate or charge impact of the issues decided by the Commission. The Commission further finds that the submitted reconciliation satisfies the

requirements of Section 386.420.4, RSMo 2016. The Commission will approve the amended reconciliation filed by Empire.
