## ORDER DIRECTING EXPEDITED RESPONSES TO STAFF REVIEW

On August 26, 2020, the Commission issued its Report and Order (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence) authority to purchase Port Perry Service Company, which provides both water and sewer service in areas of unincorporated Perry County. The Order required Confluence to file Adoption Notice tariff sheets within ten days after closing on the purchase, which were filed on October 5, 2020. The tariff sheets have a proposed effective date of November 4, 2020.

On October 16, 2020, the Staff of the Missouri Public Service Commission (Staff) filed an expedited recommendation affirming that the tariff sheets comply with the Commission's Order.

### THE COMMISSION ORDERS THAT:

1. Parties wishing to respond to the Staff recommendation must do so no later than 2:00 p.m. on October 22, 2020.
2. This order shall be effective when issued.
