## ORDER RECOGNIZING NAME CHANGE

Issue Date: October 16, 2020

Effective Date: October 30, 2020

CenturyLink Communications, LLC submitted a letter dated September 29, 2020, advising that it has changed its fictitious name to CenturyLink Communications, LLC d/b/a LUMEN Technologies and CenturyLink Communications, LLC d/b/a LUMEN Technologies Group. CenturyLink Communications, LLC d/b/a LUMEN Technologies Group has also filed a tariff to adopt the tariff of CenturyLink Communications LLC. That tariff carries an effective date of October 30, 2020.

The Commission's Staff filed a recommendation on October 15, 2020, indicating CenturyLink Communications, LLC. has complied with all statutory and regulatory requirements for changing the name by which it does business in Missouri. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of CenturyLink Communications, LLC to CenturyLink LLC d/b/a LUMEN Technologies and CenturyLink Communications, LLC d/b/a LUMEN Technologies Group.

2. The revised tariff filed by CenturyLink Communications, LLC d/b/a LUMEN Technologies Group, (Tariff No. YL-2021-0087) will be allowed to take effect on October 30, 2020.

3. This order shall be effective on October 30, 2020.

4. This file shall be closed on October 31, 2020.
