## STATUS REPORT

**COME NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through the Staff Counsel’s Office, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), and the Office of the Public Counsel (“Public Counsel”) (collectively “the Parties”) and hereby file their *Status Report* pursuant to the May 1, 2020, *Order Directing the Parties File a Status Report*. In support thereof, the Parties state as follows:

1. On April 30, 2020, the Parties filed their *Third Status Report*, providing an update on the progress made in the Affiliate Transaction Rule (“ATR”) workshop, File No. AW-2018-0394, and indicating that the Parties continued to believe the best course of action was to pursue an ATR rulemaking, and to continue the stay in the Ameren Missouri CAM proceedings in the interim. On May 1, 2020, the Commission issued an order directing the Parties to submit a further status report on July 31, 2020.

2. Since the issuance of the Commission's May 1, 2020, order, progress in the AW-2018-0394 docket has been significantly hindered by the ongoing COVID-19 pandemic emergency. However, the Parties continue to agree that the best course of action is to pursue updated ATRs, and continue the stay of the above-captioned CAM proceedings.

**WHEREFORE** Staff, Ameren Missouri, and Public Counsel pray the Commission will accept their July 31, 2020, Status Report.
