ORDER DIRECTING NOTICE

On November 17, 2000, Laclede Gas Company (Laclede or Company) filed a proposed tariff which included a number of modifications to Laclede's Gas Supply Incentive Program (GSIP). The GSIP is currently scheduled to expire on September 30, 2001. The proposed tariff bore an effective date of December 18, 2000.

On December 11, 2000, the Staff filed a Motion to Suspend Tariff, requesting that the Commission suspend the tariff sheets and schedule an early prehearing conference to facilitate further discussions among the parties. The Commission issued an Order Suspending Tariff and Setting Early Prehearing Conference on December 14, 2000, suspending the proposed tariff to April 17, 2001. An early prehearing conference was held January 19, 2001. On February 15, 2001, the Commission issued an Order Adopting Procedural Schedule and Further Suspending Tariff. In order to accommodate the procedural schedule proposed by the parties, the tariff was further suspended until October 17, 2001.

The Commission finds that proper persons should be allowed 14 days from the issuance of this order to file a motion for leave to intervene. The Commission determines that notice of this proceeding shall be given by the Commission's Records Department sending a copy of this order to the parties of In the Matter of Laclede Gas Company's Gas Supply Incentive Plan

(GSIP II), Case No. GO-2000-395. In addition, the Records Department should serve a copy of this order upon the County Commissions of each county in Laclede's service area and to the municipality of St. Louis. The Information Officer of the Commission should provide notice to the members of the General Assembly representing Laclede's service areas and to the newspapers which serve Laclede's service areas, as listed in the newspaper directory of the current Official Manual of the State of Missouri.

Proper persons wishing to intervene shall have 14 days from the date of this order to file an application to intervene with the Secretary of the Commission and shall send a copy of the application to intervene to all parties as directed below.

IT IS THEREFORE ORDERED:

- 1. That the Records Department of the Commission shall send notice of the proposed tariff sheets to the parties of *In the Matter of Laclede Gas Company's Gas Supply Incentive Plan (GSIP II)*, Case No. GO-2000-395.
- 2. That the Records Department shall send a copy of this order to the County Commission of each county in Laclede Gas Company's service area and to the municipality of St. Louis.
- 3. That the Information Officer of the Missouri Public Service Commission shall send notice to the members of the General Assembly representing Laclede Gas Company's service area, and to the newspapers which serve Laclede Gas Company's service area as listed in the newspaper directory of the current Official Manual of the State of Missouri.
- 4. That any party wishing to intervene in this matter shall file an application no later than March 14, 2001, with:
