# **STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), (collectively "the Parties"), by and through counsel, and hereby file their *Status Report* pursuant to the Commission's January 23, 2023, *Order Directing the Parties File a Status Report*. In support thereof, the Parties state as follows:

1. No further progress has occurred in this *Cost Allocation Manual* ("CAM") proceeding. With respect to the Affiliate Transaction Rule workshop docket, File No. AW-2018-0394, the Staff recently (On July 18. 2023) filed its Staff Status Report and Request for Comments on Estimated Cost Impacts Regarding Draft Affiliate Transactions and HVAC Rules, in which Staff provided an updated draft of revised Affiliate Transaction rules and indicated that in Staff's opinion such draft is ready for the Commission to move forward with a formal rulemaking if it desires to do so.

2. Given the foregoing, the Parties continue to agree that future progress in this CAM proceeding will be greatly impacted by the potential promulgation of new affiliate transaction rules, and thus recommend the Commission continue the stay of these proceedings.

WHEREFORE, Staff and Ameren Missouri pray the Commission will accept their July 27, 2023, *Status Report*.
