On May 5, 2025,¹ Mr. Michael Perkins filed a complaint with the Missouri Public Service Commission against Missouri-American Water Company (Missouri-American). On June 18, the Commission granted the parties' request for mediation. On July 18, Mr. Perkins filed a notice withdrawing his complaint.
