## PUBLIC COUNSEL'S REQUEST FOR LEAVE TO FILE SURREBUTTAL TESTIMONY AND MOTION FOR EXPEDITED TREATMENT

COMES NOW the Office of the Public Counsel and for its Request to File Surrebuttal Testimony and Motion for Expedited Treatment shows the Commission as follows:

- 1. The Commission on or about February 15, 2001 issued its Order Adopting Procedural Schedule and further suspending tariff. This Order scheduled the filing of Laclede Gas Company's surrebuttal testimony on May 17, 2001. Said Order did not allow any other parties to file surrebuttal testimony. Subsequently the deadline for filing surrebuttal testimony was extended to May 24, 2001 by an Order dated May 3, 2001.
- 2. On or about May 4, 2001, the Staff filed its rebuttal testimony wherein it set out its proposal for allowing Laclede Gas Company an opportunity to profit from its natural gas procurement activities. Staff's testimony requests the establishment of a new and different type incentive plan for Laclede Gas Company.
- 3. The Office of the Public Counsel wishes to respond and raise any concerns it may have regarding Staff's proposed new incentive proposal.
- 4. 4 CSR 240-2.130(7)(d) provides that surrebuttal testimony shall be limited to material which is responsive to matters raised in another parties rebuttal testimony. The Office of

the Public Counsel seeks leave to file surrebuttal testimony to the matters raised by the Staff in its

rebuttal testimony filed in this matter.

5. Public Counsel has contacted the Staff and the Staff does not object to Public

Counsel filing such surrebuttal testimony. Public Counsel has also made Laclede Gas Company

aware of its intention to file said surrebuttal testimony.

6. Public Counsel requests that the Commission grant this request expedited treatment

and issue a ruling on the request no later than May 22, 2001. Public Counsel believes it is

important that the Commission receive Public Counsel's input on any proposal made to allow an

incentive on Laclede Gas Company's natural gas procurement. Public Counsel has filed this

pleading as soon as it could have after reviewing and analyzing the rebuttal testimony filed by the

Staff in this matter.

WHEREFORE, the Office of the Public Counsel requests the Commission issue its order

allowing Public Counsel to file surrebuttal testimony in the above-referenced matter no later than

May 22, 2001 and for other relief which the Commission deems appropriate.
