On June 1, 2017, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively referred to as "the companies") filed their Integrated Resource Planning (IRP) 2017 Annual Updates, as required by Commission Rule 4 CSR 240-22.080(3). The companies held a stakeholder workshop on June 23, 2017, and on June 29, 2107 filed notices indicating that they would make no changes to their filings in response to those discussions.

On July 28, 2017, comments were filed by the Natural Resources Defense Council, the Office of the Public Council, and the Missouri Department of Economic Development – Division of Energy. Each of the commenters indicated that the companies' filings were deficient in some manner and described additional information they thought was lacking from the annual filing.

As noted by some of the commenters, 4 CSR 240-22 (Chapter 22) does not require or authorize any action by the Commission. As a result, there is no need for further decision or action by the Commission at this time. The Commission

acknowledges the comments and directs the companies to consider them in their next triennial filings. Since no further action is required by the Commission, this file shall be closed.
