The Commission opened this file on May 19, 2020, at the request of its Staff to assist Staff in its review of the status of Eligible Telecommunications Companies (ETCs) that are designated to receive federal universal service funding. That review is required by 47 CFR § 54.314, a rule of the Federal Communications Commission that requires state commissions to annually certify that all federal high-cost support provided to ETC carriers within that state was used in the preceding year, and will be used in the coming year, for the purposes for which it was intended. The Commission will ask its Staff whether the file needs to remain open.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a pleading no later than October 30, 2020, indicating whether this case should remain open.
2. This order shall be effective when issued.
