ORDER DIRECTING FILING REGARDING HEARING DATE

Issue Date: October 22, 2020

An evidentiary hearing was scheduled in this matter on July 24, 2020. On July 23, 2020, Spire Missouri Inc. d/b/a Spire filed a *Motion for Continuance*, requesting the Commission continue the hearing to allow Spire to exchange Complainant's meter at Complainant's request. Spire requested the Commission continue the hearing to allow the parties to attempt to resolve the case. On July 23, 2020, the Commission granted the continuance request and directed Spire to file a status report no later than September 21, 2020.

On September 21, 2020, Spire filed a status report requesting a continuance and indicating Spire had exchanged Complainant's meter. On September 23, 2020, the Commission granted the continuance request and directed Spire to file a status report no later than October 21, 2020. On October 21, 2020, Spire filed a status report indicating Spire and Complainant have not reached an agreement. Spire requests a hearing and proposes hearing dates of November 23 or December 4, 2020, and indicates Commission Staff is also available on those dates. However, Spire's status report does not confirm Complainant's availability for hearing.

The Commission will direct that if Complainant objects to hearing in this matter on either November 23 or December 4, 2020, Complainant shall submit such objection by no later than November 5, 2020. Any objection by Complainant shall identify available dates as ordered below.

THE COMMISSION ORDERS THAT:

1. Any objection by Complainant to hearing in this matter on either November 23 or December 4, 2020, shall be submitted no later than November 5, 2020. Complainant may make such submission through the Commission's electronic filing and information system (EFIS) or by mail to:

Submission by mail must be received by no later than November 5, 2020.

2. Should Complainant submit such an objection, Complainant's statement shall identify all dates he is available for a hearing in this matter from November 23, 2020, through December 2020.

3. The Commission's data center shall mail a copy of this order to Complainant by U.S. Mail addressed to Complainant's address of record.

4. This order shall be effective when issued.
